- Community Conference Funding Request
  - Discussion:
    - Last year 5 1Ls worked on the Community Conference. It is put on by the first years for the entire student body.
    - No money from the Dean's office as funding was cut last year
    - Last year the LSS gave \$3750, of which \$2500 was used.
    - Request is for: \$3500
