- (5) Motion to allocate \$50 to the purchase of 10 gift cards worth \$5 for winners of the 10 LSS Awards
 - Micah moved, Sandy seconded
 - Discussion whether cards should be from UVic (supports school); however, impractical for outgoing 3rd years
 - Taylor calls for vote on unamended motion (John to have discretion as to where cards are purchased)
 - All in favour, motion carries
- (6) Motion to fund BLA for an additional \$120 due to overspending on pizza
 - LSS has about \$800 surplus from club funding
 - BLA asked for \$500 at Club Funding Night; they were given \$250 with the understanding that they could ask for more if needed
 - Micah moved, Dani seconded
 - Questions of clarification whether BLA members should abstain from voting (no)
 - Discussion reason for overspending (unclear, seems to be accounting error); note that
 pizza was for end of year exam prep; BLA has residual funds that would cover cost,
 anything not covered would be covered personally; for next year, clubs need to ask for
 additional funds PRIOR to spending them
 - Sandy calls for vote
 - Fourteen in favour, one opposed, one abstention

(8) Discussion on LCO

- Do we need to upgrade?
 - Concerns raised by current students
 - Issues with OCI process; particular frustration with those who were not successful/did not participate in OCIs
 - Excessive focus on OCIs, given the small percentage of students that actually get jobs that way
 - Is the problem that there are no jobs or that we are not allocating enough resources?
 - UBC has a significantly larger LCO (slightly higher tuition, larger volume of students)
 - There may be a lower expectation from firms re UVic students (we seem not to receive the same level of preparation)
 - Problems with scheduling why is the LCO having sessions just before exams?
 - Perhaps there should be a primer scheduled early in 1L
 - Might be helpful if the LSS circulated a list of LCO events/calendar so students will know in advance – possible to give this out on day 1
 - Possible to do a lunchtime session early in 1L/during legal process

- Balancing increased role of LCO with need for individual student initiative
- Suggestion that the LCO could hire a student to assist (two birds, one stone)
- What is the scope of the LSS' authority here what are we able to do?
 - We can raise tuition/student fees to potentially hire an additional LC Officer
 - We have not had any discussions with the current LCO we would get their thoughts before doing anything
- Should we raise tuition fees?
 - What kind of increase would be sufficient to implement changes?
 - o Importance of our low tuition makes us more accessible, major selling point
- First step would be to communicate with the LCO and possibly the Co-op office
 - Micah to meet with Heather to discuss
 - We should also look at what is done at other schools we want to remain competitive
