(2) Business

- Surplus Funds Proposed Order for Discussion
 - Community Conference 2015
 - Motion to grant \$3000, with option for further funds if needed Micah
 - Seconded Dora
 - Discussion
 - \$2500 would be half of what was spent last year
 - Call for a vote Sandy
 - 12 in favour, 0 opposed, 1 abstention motion passes
 - Club funding surplus pool (for future events)
 - Rather than granting set amounts, we will create a slush fund clubs can apply for additional funding
 - The "slush fund" will be whatever funds are remaining after everything is allocated it can be used for clubs and other things
 - James We should allocate a set amount to clubs
 - Micah Let's look at other items, then revisit
 - \$2560 remaining after all other allocations
 - \$1000 to be allocated for additional club funding

- James There's still lots of money in the original club funding budget, so \$1000 should be plenty
- Rupi Are we going to advertise that this money is available? Yes
- \$1560 to be moved into a general slush fund
- ILSA event
 - Motion to grant \$500 to host event Micah
 - Seconded Nathan
 - Discussion
 - What event? It's an alumni dinner to be held at the University Club or an off-campus restaurant
 - Funding would be subject to the LSS Club Funding Guidelines (reimbursement, with receipts; no funding for alcohol)
 - Will \$500 be enough? Yes, as LSS funds will be added to existing funds (providing approximately \$1000 total)
 - Is the ILSA bake sale to fundraise for this? No, the bake sale is to raise money for grad
 - Call for a vote Dani
 - 7 in favour, 0 opposed, 6 abstentions motion passes
- o Intramural teams (split between teams)
 - Motion to grant \$2000 to intramural teams, to be apportioned among teams with open memberships – Micah
 - Seconded Nathan
 - Discussion
 - Dora, Dani Can we make this more like club funding (i.e. teams can come make applications for funding), since different teams have different needs, membership, etc.?
 - James This will use up time at LSS meetings; suggest allocating funds, which can be used or not (just like clubs), but a team can come talk to us if they need more
 - Rupi, Sandy Clarifying that jerseys will be kept by the school, not the players
 - Carolyn Can teams that don't use this money this year still get access next year?
 - James to include this in the budget for next year
 - Call for a vote Janessa
 - 11 in favour, 0 opposed, 2 abstentions motion passes
- Remainder
 - Amicus to be addressed later (when Rachyl is here)
 - Lounge to be addressed later (no quotes, no consultation with the Dean)
 - Cleaning supplies can be purchased out of the cleaning budget
 - Tea kettle for lounge let's use the one from the LSS office
 - We can also ask students who are moving away if they have kettles or microwaves they no longer want
 - Alternative career panel money was granted last week
 - Legal Information Clinic Emma

- LIC is changing formats to give legal advice going forward
 - Want to make the clinic year-round (not just September-April)
 - Asking for money for resources to sustain the clinic through the summer - \$500
- Motion to grant \$500 to the LIC Micah
- Seconded Nathan
- Discussion
 - James Other sources of revenue? Yes, these would be used to help with the transition
 - James Is the funding from last semester (\$500) gone?
 Mostly, to fund training sessions, photocopy costs, gifts for speakers/supporters
- Call for a vote Dani
- 13 in favour, 0 opposed, 1 abstention motion passes
- Cost of class composite photo Sarah
 - Yvonne is looking for funding, but unlikely to cover the entire cost
 - Worst case scenario, it'll cost \$330-415
 - Carolyn, Sandy Why not take this to the UVSS or the Senate since this cost was a result of a UVic policy?
 - o Ivelina is the Law rep on the Senate Kat to mention it
 - James, Micah Why are students paying for this? At the very least, the faculty should cover it
 - o If the faculty says we need a composite, they should pay
 - Discussion tabled for future consideration wait to see what Yvonne says
- Multicultural lunch Mikey
 - IHRLA to potentially host could apply for additional club funding
