 - Lobbied UVSS regarding healthcare plan that was changed without consultation
 - o Disproportionately affects law students because of age
 - Resulted in a referendum
 - More work to be done

- Budget still on track
- Still waiting on revenues from student fees, Legal Who, grad tickets
- Should meet 9500 for planned revenue
- Expenses on track. Majority planned to be under budget.
- Orientation fundraised beyond expectations so LSS approved over expenditure
- Working to deplete FASS account

VI. Special Resolutions:

a. Constitution Amendment

(Action)

- Chelsea Harris moves that LSS move to make changes contained in Appendix 1 effective April 30th
- Megan Chambers seconds
- Discussion:
 - First amendment is to change constitution
 - Updates purpose statement, includes promoting wellness initiatives
- Vote: all in favour, no abstentions
- Motion passes

b. Bylaw Amendments

(Action)

- Chelsea Harris: move that LSS change bylaws contained in Appendix 2 of the constitution and bylaw amendments documents
 - Megan Chambers seconds
 - Discussion:
 - Changes made to reflect new Societies Act, and how LSS has operated in terms of structure for the past two years

- One downside: increased number of directors that need to be reported to registrars. Justified by reported structure more accurately reflecting structure of LSS.
- Vote: all in favour, no abstentions, motion passes
- Chelsea Harris: move that the LSS move to update the bylaws to reflect changes in Appendix 3 of the constitution and bylaw amendment documents
 - Clay Gray seconds
 - o Discussion:
 - Intention was to reflect ILSA's nature as a parallel student organization to the LSS
 - Developed in consultation with ILSA members over multiple years and establishes predictable funding for ILSA while encouraging cooperation between the two organizations
 - Reflects commitment to work with ILSA to develop responses to TRC calls to action
 - Around \$6800 of additional funds will be directed to ILSA, an increase of about \$4500
 - LSS is confident budget is sustainable with this change. LSS has had a surplus greater than the proposed additional funding for each of the preceding 5 years
 - Will be supplemented by additional student fees from JD/JID program
 - o Vote:
 - All in favour, none against
 - Two abstentions
 - Motion passes
- Chelsea Harris: move to update the bylaws to reflect changes in Appendix 4 of the constitution and bylaw amendment documents
 - Ian Gauthier seconds
 - Discussion:
 - Reflects real operations of LSS
 - Adds an ILSA 1L representative
 - Puts changes in external policy documents that can be updated by future boards; adds flexibility
 - 1L coordinators want more help; opportunity to promote inclusivity through increased involvement in planning by ILSA 1L rep, who will work with other 1L reps to plan orientation and re-orientation reps.
 - Vote
 - All in favour, no abstentions
 - Motion passes

- Chelsea moves that the LSS move to update bylaws to reflect changes contained in Appendix 5 of the constitution and bylaw amendment documents
 - Megan Chambers seconds
 - Discussion:
 - Will streamline election process and reduce future potential for controversy
 - Timeline of elections process reduced to 2-3 weeks
 - Proposed amendments require future LSS boards to maintain election rules document that can changed by board at meetings.
 - Previous bylaws required this document but there never was one.
 Election fell totally under CEO (typically VPSA).
 - o Vote:
 - All in favour, no abstentions
 - Motion passes
