IV. APPEAL funding pitch

- Appeal is a course
- Club component:
 - o Review session for publishing this year's issue of Appeal
 - o Some events for the year
- Celebration of the publication of the journal
- Broader community involvement:
 - o Submissions from students across the country
 - o Seeking external reviewers across the country
- Increasing digital footprint (CanLII, Westlaw, etc)
- Podcast
 - o Taking place in different forums across Canada
- Sponsorship:
 - o Journal operating at a deficit
 - o Concern re long-term sustainability
 - o Lost ~\$200 last year
 - Graphic design and distribution are constant costs
 - Same graphic designer
- Revenues
 - o Firm sponsorship, royalties, fundraising
 - o Received \$1000 from LSS last year and still lost money
- Currently not able to raise as much as spending
- Fall party:
 - o Tickets by sale
- Launch party:
 - o Free event
- Last year revenues:
 - o \$2,750 from law firms
 - o \$4,600 from fundraising (but cost \$2,800 for event)
 - o \$400 royalties
 - o \$200 subscriptions
 - o \$250 miscellaneous
- Ouestions from the Board:
 - o JID focus to the journal this coming year?
 - Need to discuss as a board the direction of the journal
 - Balance of acceptance of entries and having enough content to be published
 - o Fundraiser event:
 - Halloween event last year
 - Mid-November this year
 - What will you have to cut if not enough funding?

- \$6,000 currently in bank accounts
- Need to raise money for \$9,000 total
- LSS has not traditionally sponsored Appeal only last year. Could you speak to why the School doesn't fund Appeal?
 - Confusion around Appeal not being an LSS Club rather than a course
 - Appeal to meet with Dean to possibly get funding for the podcast, next week
 - Although not a club, far-reaching audience, large part of student life
- This is a large financial ask. Could you speak to the other fundraising sources?
 - Alumni relations office to send letters out to law firms
 - Increasing amount asking for from firms
 - Speaking to the dean next week but unsure of whether that will be fruitful
 - If we can get more firms to give a bit of funding would be helpful
- Have you spoken to JID financial officer for revenue re Aboriginal firms?
 - We have not, but we are willing to look into it.
- o Is it possible to do more fundraisers?
 - Yes but concern re board workload
- o Could you get reviewers involved with planning?
 - It's a possibility
- You cut 11 papers, is that reflected in printing and publication expenses?
 - That would have no impact on the finances
- Long term has Appeal been profitable in the past? What has changed? What can
 be done to make it so that you are not dependent on LSS in the future?
 - What changed:
 - Limited historical data
 - As firms have become more national, tend to fund less
 - E.g. consolidation in Ontario = less funding for B.C.
 - Firms going national less inclined to fund
 - Re Regular sponsorship from LSS:
 - Have to consider this as a board in terms of cutting costs
 - E.g. last year sent a "final version" to editor multiple times → higher fees
- Vote:
 - o Motion to approve Appeal funding request (Kurt). Jeeti (Second).
 - No approvals
 - All but 1 deny
 - 1 abstention
- LSS decision rationale:
 - o Appeal is a fantastic course it is valuable and the members do great work
 - o LSS is not in a position to fund a non-LSS club
 - Not in the interest of the student body
 - We could lobby to the school administration to potentially provide funding for Appeal

V. Elections results re public postings

- 1L students expressed concerns re percentages and amount of votes that are posted in public
- Re transparency
 - o Ideas:
 - Making sure that information is available and easily accessible but not publicly posted
- LSS executive feedback:
 - o Re transparency there may be people who want to access result statistics
 - Accessible but not publicly posted could be accessed could be a compromise
 - o How about doing first second third percent difference but not requirement?
 - We need more time to look into this
 - Laura Floyd will look into bylaws and Societies Act
 - o Maybe include in our email whether/why it is a requirement to post results
